3. Speakers



CARVALHO HERNANDES Helke

Helke is currently the EFMD Global Vice President. Helke is in charge of international development managing the Hong Kong and Miami offices.

Prior to this position, Helke was the Director of Marketing, Communications and IT at EFMD and also served as the Executive Director of AHRMIO - The Association of HR Management in International Organisations, a network dedicated to furthering the management of people in not-for-

profit international organisations in the governmental and non-governmental sectors.

Since 2012 Helke sits on the CEIBS (Chine Europe International Business School) Board of Trustees as the European observer.

Helke started at EFMD in 2001 in the Networking Unit after graduating from Solvay Business School where she completed a Master on International Trade. She was a project manager and subsequently manager of three networking groups within EFMD: MBA, Undergraduate and Public Sector. She moved to the marketing department in 2007 as manager with the responsibility of building the department.

Before joining EFMD, Helke worked for ten years at HSBC Bank Brazil where her last position was account manager. She received a Chemical Engineering degree in 1994 from UNAERP in Brazil. Helke completed her MBA programme at ESCP Europe in 2007. For two years she was the Director of International Relations of the ESCP Europe Club MBA - the Executive MBA alumni group.



Aurélien Decamps has been a Professor at KEDGE Business School since 2012. Dr. Holzmann is a senior lecturer at the School of Management and Economics in The Academic College of Tel Aviv Yaffo where she also serves as the Director of Research, Development and Innovation. Vered received her doctorate from the School of Management, Tel-Aviv University. Her work has been presented in international conferences and published in books and scholarly journals including Project Management Journal, International Journal of Project Management, The Learning Organization, and European Journal of Education.

Vered participated in several European projects and coordinated Tempus and Erasmus+ projects. She is the coordinator of Erasmus+ project IFI (Innovative Finance in Academic and Field) and recently received a grant from the Edmond de Rothschild Foundation for research on Impact - Economic Models for Israeli Public Higher **Education Institutions.**

Vered is a project manager (PMP, SCM) with experience in the IT industry, engineering and construction on one hand, and in the political, marketing and higher education environments on the other hand. She held various managerial positions in several startup enterprises and currently serves as a member of the PMI (Project Management Institute) Academic Insight Team.

SCHOENMAKER Dirk

Prof. Dirk Schoenmaker is Professor of Banking and Finance at the Rotterdam School of Management, Erasmus University Rotterdam.

His research and teaching focus on the areas of sustainable finance, central banking and financial stability, financial system architecture and European financial integration. He is regular speaker at academic and professional conferences.

Dirk Schoenmaker is also a non-Resident Fellow at the Brussels-based think tank Bruegel and a Research Fellow at the Centre for European Policy Research (CEPR). He is co-author of the textbooks 'Principles of Sustainable Finance' (Oxford University Press) and 'Financial Markets and Institutions: A European perspective' (Cambridge University Press) and author of 'Governance of International Banking: The Financial Trilemma' (Oxford University Press). He earned his PhD in economics at the London School of Economics.

Before joining RSM, he was Dean of the Duisenberg school of finance from 2009 to 2015. From 1998 to 2008, he served at the Netherlands Ministry of Finance. In the 1990s he served at the Bank of England. He is a regular consultant for the IMF, the OECD and the European Commission.



STEFANOU loannis

Ioannis Stefanou brings multiple years of professional experience in the energy sector. He holds a Diploma in Electrical and Computer Engineering from the Technical University of Patras and a 2-year MSc in Sustainable Energy Technologies from Delft University of Technology on Sustainable Energy Technologies.

During his professional career he has gained a profound understanding of the EU acquis in the energy sector, the

regulation of transmission and distribution networks both from an economic and technical standpoint, and the operation of the wholesale and retail energy markets, as well as EU policies on the climate change and energy transition. Ioannis has implemented numerous projects related to the development of policy and regulatory frameworks, market restructuring and liberalization, development of business strategies, regulatory economics, sustainable development and decarbonisation.

Finally, he has been one of the focal experts on the preparation of the Greek Recovery and Resilience Plan, responsible for the Green Transition and largely involved in its implementation.



TERRASSE Christophe

Dr. Christophe Terrasse is the Director of the International Projects Department at EFMD, in charge of all the EU-funded projects in the field of Higher Education and International cooperation with European and non-European institutions.

He oversees all the projects in which EFMD is in charge of QA, monitoring and impact assessment, including knowledge alliances and H2020 projects.

Since he joined EFMD in 2000, he has coordinated and managed more than 60 international projects implemented all over the world, linked to internationalisation, HE impact, digitalisation of HE, internationalisation and modernisation of higher education systems.

In June 2015, Gilles Vandeburre became member of the Belgian Federal Parliament, as a substitute for Zakia Khattabi who become co-president of Ecolo. Gilles Vandeburre was then re-elected in 2019 as member of the Belgian Federal Parliament.

He is a business engineer and has worked for 12 years in the business world in various commercial executive positions, in the banking and industrial sectors and has managed a

business incubator linked to sustainable development and the environment (Greenbizz).

Convinced that ecology remains more than ever the future of the economy, his political priorities are focused on entrepreneurship, SMEs and the self-employed with particular attention to the relocation of our economy and innovation (circular economy, collaborative, functionality, etc.).























In October 2020, he became the leader of the Ecolo-Groen group in the Belgian Chamber. At the Belgian Federal Parliament, the areas and committees in which he is active are:

Address: Rue Gachard 88, Ixelles 1050, Brussels

To enter the building: Please use the arrows on the bell to find "EFMD". Ring the bell and then you can enter the building.

Floor: 4th floor. Please use the last 2 elevators, the EFMD staff will welcome you at the 4th floor.

Directions to EFMD

Walking: From the historical city centre (around Grand Place) until EFMD, it is approximately 40' walking.

By Metro: "Louise" is the nearest metro station. From "Louise" someone can walk until EFMD within 15-20' (the ticket fare is 2,60 euros from the machines at the metro stations).

By Tram: "Vleurgat" is the nearest tram station. The trams 8 & 93 stop at "Vleurgat". EFMD is 5' walking distance from "Vleugart" (the ticket fare is 2,60 euros from the machines at the tram and bus stops).

By Taxi: A taxi from the historical city centre (around Grand Place) to EFMD costs approximately 15 euros.















5. Transportation from the airport to the city

By train: You can find the train at the level -1 of the airport. It stops at the main train stations of the city; Gare Central, Gare du Nord and Gare du Midi. The price of the ticket is 9,30 euros.

By bus: Bus n° 12, can be found at the level 0 of the airport and can take you until Place Luxembourg from where you need other transportation until the city centre or EFMD. The ticket price is 7 euros.

Taxi, Uber etc.: It costs approximately 50 euros until the city centre (e.g., until Gare Central).

Interesting sightseeing:

 - Walk until "Palais de Justice" and towards the Magritte Museum, Park Royal, the Royal Palace and Place de la Monnaie until Grand Place.

What to try:

- Belgian chocolates and waffles. Big variety can be found in the city centre, but the most popular ones can be found almost everywhere in the city.
- Belgian beers (such as trappist beer). Big variety can be found in the historical centre, but the most popular ones can be found almost everywhere in the city.
- Mussels & frites: a typical dish in Brussels. There are plenty of restaurants in the small streets around Grand Place and in Place Saint Catherine.
